Your credit will be applied to final payment made by Main Street Golconda back to vendors following the festival. Vendors registering after June 28th, 2024 are not eligible for this special promotion. Vendors who do not show to the festival or who leave early, without prior approval by the festival board, will forfeit their booth deposit fee.**

#### Shrimp Festival Guidelines:

- 1.) **As a Major Food Vendor, it is mandatory that you serve at least one shrimp dish and plan to serve that dish all day.** While we certainly encourage a wide-variety of foods to be offered at our festival, guests are coming for dishes related to shrimp and we expect each vendor to be serving shrimp. If you would like some suggestions on menu ideas or ways to differentiate your food, please contact us and we'll be glad to help you stand out.
- 2.) **Menus must be forwarded to the Main Street Office no later than August 30th, 2024.** Please include your items and prices so we can publish them in advance and help promote your offerings. All menu items must be priced in \$1.00 increments.
- 3.) Vendors agree to only accept tickets. **There are no cash sales allowed.** Tickets need to be turned back into the festival office no later than 10:30 p.m. on the evening of the festival for tabulation. Final ticket tallies will be provided to you prior to your departure from the festival. Reimbursement checks will be sent out by mail the following week after the festival. This festival is a fundraiser for our non-profit organization. Vendors who violate our ticket sales policy will be asked to leave and will forfeit their booth deposit.
- 4.) **Please make sure you have read through the Vendors Rules & Procedures** document for information on FAQ's and submit the Hold Harmless Clause located at the end of the document.
